

FREELAND MUNICIPAL AUTHORITY WATER & OR SEWER AGREEMENT

by and between **THE BOROUGH OF FREELAND MUNICIPAL AUTHORITY**

herein after referred to as “**AUTHORITY**”, and _____

hereinafter referred to a “**OWNER**”.

Whereas, the property situated at _____ Street in **FREELAND**, Luzerne County, Pennsylvania, is presently connected or about to be connected to the central **WATER/SEWER** System of the **BOROUGH OF FREELAND MUNICIPAL AUTHORITY**; and whereas, the owner desires to enter into an agreement and hereby makes application for **WATER/SEWER** service to serve the above-described premises: and whereas _____ warrants and covenants that he/she is the entire owner of the premises above described.

Customer/Owner hereby certifies that, at the time of this Agreement/Application, he/she does not have outstanding any unpaid balances for water or sewer services provided to the Authority at the above or any other location.

How, therefore, intending to be bound, the parties hereto agree as follows:

The Authority agrees to supply in so far as such supply is available or services are available, the services requested by the Owner and the Owner hereby agrees to be bound fully by the rates, rules and regulations of the BOROUGH OF FREELAND MUNICIPAL AUTHORITY, both Water Division and/or SEWER DIVISION, a copy of which rates, rules and regulations are available for review and inspection on normal business days at the Office of the Authority, 711 Birkbeck Street, Freeland, Pennsylvania. They are also available on our website, www.fmaws.org.

The owner acknowledges that being given this opportunity to review and inspect the rates, rules and regulations are available for their inspection and they have a right to review and inspect the rates, rules and regulations prior to the execution of this agreement and should they decide not to inspect the rates, rules and regulations prior to the execution of this agreement, they hereby waive their review and inspection of said rates, rules and regulations.

In the event that the OWNER is only an occupant of the premises above described, this Agreement is also being executed by the owner of the premises, which OWNER agrees to be responsible and covenants and warrants that he/she is the OWNER of the premises above described and agrees to comply with all the rates, rules and regulations of the AUTHORITY in so far as the rates, rules and regulations pertain to them premises being supplied service. The OWNERS to the property act and sign as a guarantor for the payment of the bills for the services rendered to the premises and also convenient and agree and save harmless the AUTHORITY from any non-performance of the requites of the rates, rules and regulations of the AUTHORITY insofar as the tenant and/or the owner are concerned.
